Food Pantry (The Market) - Our focus is a food pantry to ensure nutritional food is accessible to those hungry or food insecure. We provide fresh produce, proteins, and dairy in a grocery store choice model. In fiscal-year 20-21, the organization served 9,210 clients from 2,470 households through this program.

4b (Code:) (Expenses \$ 234,476 including grants of \$ 218,190) (Revenue \$ 0)
Food4Kids - The Kids Backpack Program provides kid-friendly weekend food for at-risk students on the weekend so they are nourished and ready to learn when they return on Monday. This program also engages youth through leadership development programs. In fiscal-year 20-21, the organization served about 1,000 students through this program.

Other Programs - The Basically Needed Program provides diapers, personal care items, pet food, and crisis support. In addition, The Garden Program provides fresh produce to our customers. In fiscal-year 20-21, the organization served 913 people from 201 households with this program.
